

#### MESSAGE FROM THE INTERIM MINISTER

"Scrooge, Snoopy, Shepherds and God"

The coloured lights marked the top rail of the fence in front of a rural property. The coloured lights were a welcome sight in the late afternoon as we go deeper into the darkness of this new daylight time. A bit too soon you say?

A bit too soon for holiday shows on television or in the community? Television has been showing holiday specials for a few weeks now. A friend told me that Christmas would not be complete without watching his favourite, Alistair Sim in Christmas Carol. The list is endless, from Miracle on 34th Street, It's a Wonderful Life, to Snoopy's Christmas. Christmas and Advent are filled with secular and sacred, reindeer mixing with angels, shepherds with Santa Claus, elves with evanvangelism, Messiah with Rockin' Round the Christmas Tree. So many themes gather momentum during the holiday season.

Even the themes of church plays appear to blend the narratives of Jesus' birth, which one reads only in the Gospels of Matthew and Luke. Matthew's narrative begins with a genealogy which lets the reader know that Jesus descended from David, but also from Abraham. Hence, the argument is being made that Jesus is the long-awaited Messiah for the Hebrews as

well as for all humankind. Joseph, the main actor for Matthew, plans to legally dismiss the pregnant young Mary to whom he is betrothed, but his fears are quieted by the angel of the Lord. Jesus is born in Bethlehem, visited by wise men, popularly seen as three, but not so numbered in the narrative. Joseph then takes the family to safety to Egypt, returning to Israel only after evil King Herod dies some years later.

Luke's gospel talks nothing about wise visitors, gifts or trips to Egypt. In Luke, the birth of Jesus takes place in a stable, or manger, and the visitors are local shepherds. At the beginning of this narrative great emphasis is placed on the pious Jewish characters, priest Zechariah and his wife Elizabeth, and on Mary who has found favour with God and will conceive a son. These three characters alternately are speechless, sing songs of praise and prophesy. Mary's words are written on the hearts of many faithful, "Here am I, the servant of the Lord; let it be with me according to your word." (Luke 1:38) Joseph's bit part has him dutifully taking pregnant Mary with him to Bethlehem for the census, with no mention of divorce or responsibility for the pregnancy. The rough and tumble shepherds are the first to hear about the birth. And at his

temple presentation, Jesus is met by the aged, devout Simeon and the aged prophet Anna, who lived most of her life in the temple. It seems important to Luke that Jesus was born and raised in a family of observant and pious Jews.

In observing the birth of Jesus, Christians blend these narratives, finding some selections useful while neglecting others. A careful reading and exploration of the texts invites an appreciation of different themes, and more broadly, an appreciation of religious traditions and cultures different than our own. "Peace on earth and justice for all will only become reality when enough sons and daughters awaken to the divine design that has made each of us in the Creator's image." (Edward Hays) May that be our prayer this Advent and Christmas, and "Here am I" servanthood for the New Year.

#### The History of Flanders Fields

In the Sunday service of Nov. 6, we rem embered the soldiers from our congregation who were killed in action in World War I (9), World War II (12) and the Korean War (1). Doug Kilpatrick also shared with us the well-known "In Flanders Fields" poem, and presented the following historical background prior to his reading. The editorial group wishes to share this with you.

A few months more than one hundred and one years ago, Lt. Col. John McCrae wrote his enduring poem IN FLANDERS FIELDS during the First World War, in the spring of 1915.

On the twenty-second of April, 1915, the German Army attacked the Allied line in the vicinity of the city of Ypres, the Flanders region of Belgium. This was the beginning of the Second Battle of Ypres.

For the first time in the history of warfare, the German Army made extensive use of poison gas in the attack. Allied soldiers had no defense against the gas. Off the flank of the Canadians, the Allied line broke, but the Canadians held and were able to help close the gap.

The cost was terrible. Over eleven days, Canadian casualties, wounded, missing and killed, were more than five and a half thousand, of whom fatal casualties were almost two thousand. Among the names on the Smiths Falls cenotaph are the names of four young men from Smiths Falls whose lives were taken in that battle.

During the battle, John McCrae served as a Canadian Army Field Surgeon in an Advanced Dressing Station.

In the aftermath of the battle, and in the aftermath of the death of a good friend killed in action, McCrae wrote words for those soldiers who could no longer speak for themselves. He wrote:



In Flanders fields the poppies blow Between the crosses, row on row That mark our place; and in the sky The larks, still bravely singing, fly Scarce heard amid the guns below.

We are the Dead. Short days ago
We lived, felt dawn, saw sunset glow,
Loved and were loved, and now we lie
In Flanders fields.

Take up our quarrel with the foe: To you from failing hands we throw The torch; be yours to hold it high. If ye break faith with us who die We shall not sleep, though poppies grow In Flanders fields.

#### BOARD OF TRUSTEES REPORT

The Board of Trustees held its most recent meeting on November 24, 2016. Here is an update:

#### **Financial Report**

The total Balance of "Funds Held in Trust" as of October 31, 2016 is \$200,602.53.

There have been no deposits since the last report plus 10 cents interest on the savings account. Disbursements since the last report to you from "Funds in Trust" were bank charges totaling \$4.00. So the bank balance as of October 31, 2016 is \$5,458.26.

A Summary of Investments as of October 31, 2016 is as follows:

- The Trustee's Investment Savings Account at Scotia Bank is \$5,458.26;
- The balance in Trinity's BMO Wealth Management Investment Portfolio is \$175,144.27; and
- There is the \$20,000.00 investment in of Trinity's Gift Card Program.... for a total balance in "Funds Held in Trust of \$200,602.53.

#### **Investing Funds in Trust**

As a reminder, in late 2014, we engaged BMO-Nesbitt Burns (The Graham-Dixon Group) in Perth to provide professional advice and investment portfolio management to assist in executing our investment responsibilities. The investment strategy is to help rebuild our Funds in Trust and to provide annual income for the use of the Church, while protecting our principle

investment. Our investment strategy was reviewed in May 2016 and we agreed that this is not the time to alter our investment portfolio which is made up of GICs, a Bond Fund, an Equity Fund and a Dividend Fund. On November 24, 2016, Trustees met with Derrick Dixon of The Graham-Dixon Group to review our current portfolio and to receive a prospectus on the investment future moving into 2017 and 2018. Trustees will meet again with Mr. Dixon in mid-December 2016 to finalize any investment strategy and portfolio shifts going into 2017.

#### Legacy (Planned) Giving

The Trustees have been advised that another bequest has been made to Trinity.

We will report the details to you once the bequest has been received. We are most grateful for all gifts that are provided to the church to help us do God's work with our congregation, community and beyond.

As a reminder Trinity's Legacy Giving Program offers a variety of ways that members, adherents and friends of Trinity can make a gift to assist in sustaining the future of Trinity. Information as to the various ways that you can participate in the Legacy Giving Program, and the potential benefits are may be available to you as a donor, are available at the church.

We are currently working on a new project for the new year and are sure it will open the door to many things. Please see "Salt and Light" article below.



# TRANSITION TEAM REPORT

It has been a very busy two months since the Transition Team last reported to you through the Thanksgiving Communicator. Here is what has happened:

A Congregational Day of Discovery – "Envisioning our Future" – September 25, 2016 - The Transition Team prepared a final Congregational Day of Discovery to "Envision our Future". What is God calling us to do? The event was held following Women's Sunday worship service and Potluck Finger Food Luncheon. The results of the workshop are published in the Transition Team Newsletter #8 - October 9, 2016 and are available through the church office and on the Trinity website.

Transition Team Report to Trinity
Church Council - October 18, 2016 – The
Transition Team presented its progress
report and recommendations to Church
Council. The report and recommenda
tions were accepted and were presented
at a Special Congregational meeting on
November 13, 2016. The Transition Team
Report and the motions were made availa
ble to the Congregation through the Tran
sition Team Newsletter # 10 dated Nov. 6,
2016.

Trinity Special Congregational Meeting – Nov. 13, 2016 – was held prior to the Sunday morning worship service. The congregation passed the following five motions:

- That the congregation accepts the report of the Transition Team dated October 18, 2016.
- That the congregation transmit the Report of the Transition Team to Pastoral Relations of Four Rivers Presbytery for review, and request that a vacancy for one full-time ministry personnel position be declared for July 1, 2017.

- That the Transition Team be authorized to coordinate and complete the required forms and profiles as directed in Handbook: Declaring/Changing Ministry Positions which include The Mission and Ministry Profile, the Financial and Demographic Profile and the Ministry Personnel Personal description position, naming the Interview Team and present the completed information to Church Council, the congre-
- That the congregation affirms Church Council's adoption of the Living Mission, Vision Statement, Core Values Statement and Tag line (Motto) of Trinity United Church dated 18 October 2016.

gation and Presbytery for approval.

 That the congregation covenants with itself and with leadership for ensuring that the changes and decisions made during the Interim Ministry are carried forward into the new phase of mission and ministry.

The Transition Team Newsletter # 11 dated November 20, 2016 provided details about the work to be completed between November 13, and December 16, 2016.

Four Rivers Presbytery Meeting - November 22, 2016 - Trinity's Transition Team report was dispatched to the Four Rivers Presbytery Pastoral Relations Chairperson and will be considered at their meeting on November 22, 2016.

#### Hurricane Matthew Emergency Appeal-FAQ

Is The United Church of Canada responding to the humanitarian crisis caused by Hurricane Matthew in Haiti and surrounding countries?

Yes. As a church we are called to be one body, and to care for the whole. Our faith teaches us to care for the most vulnerable members of society. Matthew 25:40 reminds us: "Truly I tell you, whatever you did for one of the least of these brothers and sisters of mine, you did for me". The United Church lives out faith and witness in the world, steadfast in the belief that every individual must be cherished and included.

The United Church is working with Mission & Service partners on the ground. Some relief is already being distributed, and needs are being assessed.

The United Church of Canada has a long history of responding with faithful compassion.

## Will The United Church of Canada accept donations for Hurricane Matthew relief?

Yes. The United Church has launched a formal appeal.

## What will happen to my money? Will it reach those who need it in Haiti and surrounding countries?

Yes. The United Church works with local partners who have well-established and trusted distribution networks on the ground, including in remote and marginalized communities

## Does the United Church take an administrative fee off my donation?

No. One hundred percent of your donation is used for emergency response: 85 percent of your donation goes toward on-the-ground work and 15 percent is held to ensure the United Church has the financial means to immediately respond to emerging humanitarian crises, without waiting for donations to arrive. The Mission & Service fund covers the cost of staffing and other administrative expenses.

## Can my congregation give money to the Hurricane Matthew Emergency Appeal?

Yes. Your congregation can give money designated for the Hurricane Matthew Emergency Appeal.

Can I get an income tax receipt? Yes.
